Awakening Clinical Intuition: The Neurobiology of Flashes, Hunches, and Gut Feelings

Program

As psychotherapists, how do we know exactly what to do and say? Clinical intuition is indispensable to effective psychotherapy. Clinical intuition fills the gap between theory and practice through moment-to-moment, embodied perceptions unique to each person and therapeutic dyad. This interactive workshop is partly experiential, partly didactic workshop. We will integrate interpersonal neurobiology into an exploration of clinical intuition from multiple perspectives: 1) Its workings via bottom-up, implicit, nonconscious modes of communication; 2) Its evolutionary and developmental roots within mammalian limbic emotional and motivational circuits; 3) Its manifestation in ordinary as well as extraordinary ways of knowing. Clinical examples are explored, the importance of play and metaphor, dreams, and guided imagery, as well as the role of unconsciously orchestrated games that organize relational bids and rhythms of engagement, defense, and creative emergence.

Regardless of patient population or treatment modality, clinical intuition is necessary to be fully attuned to self and other in the moment, and to work effectively with the uniqueness of each individual given his or her own developmental history, cultural background, and genetic make-up.
